WHY WAS THE BOND ELECTION CALLED?

- LINDALE ISD HAS GROWN FROM 2,573 STUDENTS TO 4,075 STUDENTS IN 18 YEARS.
- LINDALE HIGH SCHOOL IS PROJECTED TO SOON EXCEED CORE & STUDENT CAPACITY.
- AT CURRENT RATE OF GROWTH, LINDALE ISD IS PROJECTED TO HAVE 5,000 STUDENTS IN JUST 10 YEARS.
- IMPROVE AND EXPAND EXTRA-CURRICULAR FACILITIES

WHAT IS PROPOSED IN THE BOND ELECTION?

THE PROPOSITION CALLS FOR SECURITY ENHANCEMENT ACROSS THE DISTRICT, EXPANSION AT LINDALE HIGH SCHOOL, INCLUDING 23 ADDITIONAL CLASS ROOMS, CAFETERIA EXPANSION, AN AUXILIARY GYM & EXTRA-CURRICULAR IMPROVEMENTS. THOSE IMPROVEMENTS INCLUDE CONSTRUCTION OF A MULTI-PURPOSE ACTIVITY CENTER AND RENOVATIONS AT EAGLE STADIUM.

WHAT IS A BOND ELECTION?

IN A BOND ELECTION, VOTERS AUTHORIZE OR DO NOT AUTHORIZE THE SCHOOL BOARD TO BORROW MONEY TO FINANCE THE CONSTRUCTION OR RENOVATION OF SCHOOLS THROUGH THE ISSUANCE OF BONDS.

TOTAL BOND REQUEST: \$32.4M

HOW WILL THE BOND BE USED?

- 23 ADDITIONAL CLASSROOMS AT LINDALE HIGH SCHOOL
- CAFETERIA EXPANSION AT LINDALE HIGH SCHOOL
- SECURITY ENHANCEMENTS (DISTRICT-WIDE)
- AUXILIARY GYM AT LINDALE HIGH SCHOOL
- MULTI-USE ACTIVITY CENTER
- SEATING, CONCESSION, RESTROOM & PARKING RENOVATIONS AT EAGLE STADIUM

WHY EXPANSION AT THE HIGH SCHOOL?

- BASED ON STUDENT ENROLLMENT PROJECTIONS, LINDALE HIGH SCHOOL WILL SOON EXCEED CORE CAPACITY.
- PROPOSED CONSTRUCTION WILL HELP REDUCE OVER-CROWDING IN HALLWAYS AND IN THE CAFETERIA.

WHAT WILL IT COST?

NO TAX IMPACT FOR SENIORS 65 YEARS AND OLDER WITH APPROPRIATE EXEMPTION

THE MAXIMUM TAX RATE IMPACT OF THIS BOND ELECTION IS PROJECTED TO BE **FOUR CENTS.**

- AN AVERAGE INCREASE OF \$4.85 PER MONTH (THE AVERAGE HOME VALUE IN THE LINDALE ISD IS \$170,456). INCLUDES HOMESTEAD EXEMPTION.

DID YOU KNOW?

THE LINDALE ISD BOARD OF TRUSTEES HAS REDUCED THE I/S TAX RATE 9.5 CENTS SINCE 2011.
